EVENT FACTS

WHERE: The Village of Grosse Pointe, Kercheval between Neff and Cadieux

WHEN: Friday, July 28 from Noon to 6:00 p.m. and Saturday, July 29 from
10 to 5 p.m.

COST: \$50 per 10 x 10 space.

Artists must supply their own tent or canopy. Some covered spaces may be available at an additional cost. Call for details and availability.

Location is not confirmed until closer to the event and is at the sole discretion of the organizers. During the Sidewalk Sale the merchants in The Village have right to display and sell in street in front of their stores.

24 Hour Security is provided at no additional charge.

Clean Family Fair! No vulgarity, or obscenities will be tolerated.

REQUIREMENTS

1. A minimum of 3 photos must be submitted to show artist's work. (Online by email attachment or website is acceptable). Photos may also be mailed in. Email to: posterityframegallery@gmail.com.
2. All mediums are welcome. Categories include paintings, prints, photography, jewelry, glassworks, metalworks, ceramics, sculpture, clothing, graphic design, etc. as long as products are designed and produced by the artist.
3. All entries will be in good taste and "family friendly". Posterity Gallery and the Grosse Pointe Village DDA reserve the right to refuse exhibitions or work that is not consistent with the artist's application for acceptance and submitted photos. We also reserve the right to accept or decline any applicant as it deems necessary and may remove all or part of an exhibit that it deems in violation of the rules. Decisions are final. Artists are required to be present on both days.

SET UP

The Village of Grosse Pointe DDA will have spaces identified and you can set up beginning at 10 A.M. Friday, July 28. There is no electrical power source available. You are responsible for bringing your own booth or tent. You may leave your art overnight, as 24- hour security has been hired to protect your art and belongings. There are no additional fees commissions, etc. Please remember that use of the interior space is YOUR responsibility – display, making sales, collecting State of Michigan sales tax (6%) and reporting those sales to the State.
